RESOLUTION FOR BOARD TO ADOPT:

RESOLVED, that the School Board of Independent School District 271 approves the Rental Agreement between the City of Bloomington and Independent School District 271 for the use of the Bloomington Ice Garden for Jefferson High School and Kennedy High School hockey season effective for the years:

November 1, 2019 – March 31, 2020
November 1, 2020 – March 31, 2021

BACKGROUND:

The District agrees to pay the City as follows:

The District will be charged a game rate of \$760.00 per game. Ticket sales for each game will be allocated as follows: first \$240.00 to City for staffing then there will be a 50/50 split of ticket sales between Bloomington Ice Garden and Independent School District 271. The term of this contract is from November 1, 2019 through March 31, 2021.

The District's legal counsel and insurance agent of record have reviewed the agreement.



BLOOMINGTON ICE GARDEN RENTAL AGREEMENT

INDEPENDENT SCHOOL DISTRICT # 271

THIS AGREEMENT is made this _____ day of _____, 2019, between the **City of Bloomington**, a Minnesota municipal corporation located at 1800 West Old Shakopee Road, Bloomington, Minnesota 55431 ("City"), and **Independent School District # 271**, located at 1350 West 106th Street, Bloomington, MN 55431 ("User").

RECITALS

WHEREAS, the City is the owner and manager of the Bloomington Ice Garden ("BIG") located at 3600 West 98th Street, Bloomington, Minnesota; and

WHEREAS, User desires to use portions of BIG for Jefferson and Kennedy boys and girls high school hockey games and the City desires to allow User to use portions of BIG subject to the terms and conditions of this agreement ("Agreement").

NOW, THEREFORE, in consideration of the terms and conditions expressed herein, the City and User agree as follows:

1. **TERM.** The City hereby permits User the rental of ice at BIG and use of facilities incidental thereto ("Facilities") at the dates and times set forth on the attached schedule, as amended from time to time, and also attached hereto as Exhibit B ("Customer Schedule"). The term of this Agreement shall be from **November 1, 2019 to March 31, 2021** ("Term").
2. **FACILITIES.** Rental includes exclusive use of one or more ice sheets, on the dates, times, and ice sheets set for in the Customer Schedule, together with non-exclusive use of the Facilities.
3. **RENTAL RATE.** User agrees to rent ice at BIG from the City for the Jefferson and Kennedy boys and girls high school hockey teams, as needed, at a rental rate of \$760.00 per game during the Term of this Agreement ("Rate"). At the conclusion of each game, a \$240.00 facility cleaning fee will be deducted by the City from total ticket sales for that game and the remaining balance from that same game's ticket sales will be divided equally between the City and the User.
 - a. The City will invoice the User monthly and the User shall pay the City all outstanding amounts within 30 days of the date of the invoice.
 - b. The City will issue the User periodic payments for the User's portion of ticket sales pursuant to the formula described in this paragraph 3.
 - c. Even if the User fails to show up for a reserved period of ice usage as identified in the Customer Schedule, the User will be charged the Rate.
4. **SERVICES.** Notwithstanding any other provision of this Agreement, the City and the User may separately agree to additional services, personnel, and staffing upon the request of the User or the recommendation of the City.
5. **RULES AND REGULATIONS/ASSUMPTION OF RISK.** The User agrees that for itself and any other person or entity using under or through User using BIG will abide by all rules and regulations adopted by the City for use of BIG and will comply with all City ordinances and State and Federal law, rule and regulation. The User also agrees that it will have a representative present at all times during its use of the Facilities to supervise the activities of any other person or entity using under or through User. THIS AGREEMENT is made this _____ day of _____, 2019, between the **City of Bloomington**, a Minnesota municipal corporation located at 1800 West Old Shakopee Road, Bloomington, Minnesota 55431 ("City"), and **Independent School District # 271**, located at 1350 West 106th Street, Bloomington, MN 55431 ("User").

RECITALS

WHEREAS, the City is the owner and manager of the Bloomington Ice Garden ("BIG") located at 3600 West 98th Street, Bloomington, Minnesota; and

WHEREAS, User desires to use portions of BIG for Jefferson and Kennedy boys and girls high school hockey games and the City desires to allow User to use portions of BIG subject to the terms and conditions of this agreement ("Agreement").

NOW, THEREFORE, in consideration of the terms and conditions expressed herein, the City and User agree as follows:

1. **TERM.** The City hereby permits User the rental of ice at BIG and use of facilities incidental thereto ("Facilities") at the dates and times set forth on the attached schedule, as amended from time to time, and also attached hereto as Exhibit B ("Customer Schedule"). The term of this Agreement shall be from **November 1, 2019 to March 31, 2021** ("Term").
2. **FACILITIES.** Rental includes exclusive use of one or more ice sheets, on the dates, times, and ice sheets set for in the Customer Schedule, together with non-exclusive use of the Facilities.
3. **RENTAL RATE.** User agrees to rent ice at BIG from the City for the Jefferson and Kennedy boys and girls high school hockey teams, as needed, at a rental rate of \$760.00 per game during the Term of this Agreement ("Rate"). At the conclusion of each game, a \$240.00 facility cleaning fee will be deducted by the City from total ticket sales for that game and the remaining balance from that same game's ticket sales will be divided equally between the City and the User.
 - a. The City will invoice the User monthly and the User shall pay the City all outstanding amounts within 30 days of the date of the invoice.
 - b. The City will issue the User periodic payments for the User's portion of ticket sales pursuant to the formula described in this paragraph 3.
 - c. Even if the User fails to show up for a reserved period of ice usage as identified in the Customer Schedule, the User will be charged the Rate.
4. **SERVICES.** Notwithstanding any other provision of this Agreement, the City and the User may separately agree to additional services, personnel, and staffing upon the request of the User or the recommendation of the City.
5. **RULES AND REGULATIONS/ASSUMPTION OF RISK.** The User agrees that for itself and any other person or entity using under or through User using BIG will abide by all rules and regulations adopted by the City for use of BIG and will comply with all City ordinances and State and Federal law, rule and regulation. The User also agrees that it will have a representative present at all times during its use of the Facilities to supervise the activities of any other person or entity using under or through User. The

User for itself and for each of its members and other persons that will use the Facilities under or through the User, hereby accepts and assumes the risks of accidents of or damage or of injury to the User or to any person using under or through User.

6. **USER MAINTENANCE.** The User shall be responsible for clean-up of locker room facilities following each use, including the pick-up and proper disposal of trash, litter and other debris left at BIG by the User and any other person or entity using under or through User.
7. **ASSUMPTION OF DAMAGE.** The User shall be liable to the City for any loss or damage arising out of User's use of BIG or its Facilities or any other person or entity using BIG under or through User.
8. **INDEMNIFICATION.** To the fullest extent allowed by law, the User for itself and for any other person or entity using under or through User agree to release and to hold the City and its officers, officials, agents, volunteers, and employees harmless and defend and indemnify the City against any claims, causes of action, lawsuits, damages, losses, or expenses, including attorneys' fees, arising out of, resulting from, or related to use of BIG by the User any other person or entity using under or through User, including but not limited to any and all claims for bodily injury or death or property loss or damage sustained as a result of use of BIG by User or any other person or entity using under or through User. Nothing in this Agreement shall be construed as a waiver of any immunity or limitation on liability pursuant to Minnesota Statutes Chapter 466.
9. **INSURANCE.** The User shall maintain Commercial General Liability insurance in the following amounts:
 - a. bodily injury in the amount of at least \$500,000 per individual and \$1,500,000 per occurrence for injuries or death arising out of each occurrence;
 - b. property damage liability in the amount of \$1,500,000 for each occurrence; or
 - c. as an alternative to (a) and (b), the User may carry aggregate commercial general liability limits of at least \$2,000,000.

The User further agrees to name the City as additional insured in said insurance policies and to provide a certificate of insurance to the City prior to use of BIG.

10. CANCELLATION OR RESCHEDULING.

- a. **BY USER.** The User shall notify the Bloomington Ice Garden Manager ("BIG Manager") of any cancellation of any ice time scheduled under this Agreement thirty (30) days prior to the time being cancelled. Except as otherwise agreed upon with the BIG Manager, all ice time set forth on the Customer Schedule must be paid for by the User whether or not User actually uses the Facilities.
- b. **BY CITY.** The City reserves the right to:
 - i. cancel this Agreement for any default or breach of the Agreement by the User or its members; and
 - ii. reschedule dates or times on the Customer Schedule if the City deems necessary. In the event of a mechanical, or other failure of the BIG equipment or Facilities that results in the User being unable to use the Facilities, the City will notify the User as soon as possible, and will reimburse fees paid by the User for any time scheduled under this Agreement when the Facilities were unavailable to the User.

11. **ASSIGNMENT.** The User shall not assign this Agreement, or any interest in this Agreement, without the express written consent of the City.
12. **ENTIRE AGREEMENT.** This Agreement, including all exhibits, represents the entire agreement of the parties and supersedes and cancels any and all prior agreements or proposals, written or oral, between the parties relative to this subject matter. Any amendments, addenda, alterations, or modifications to the terms and conditions of this Agreement shall be in writing and signed by both parties.
13. **WAIVER.** Any waiver by either part of a breach of any provision of this Agreement shall not affect, in any respect, the validity of the remainder of this Agreement.

14. NON-PROFIT ORGANIZATIONS. If a User claims non-profit status, it must attach a copy of its Certificate of Exempt Status (Form ST-17 or Form ST-3) before such status will be acknowledged for purposes of eliminating the sales tax normally due and payable on ice rental charges.

15. MISCELLANEOUS.

- a. **Additional Fees.** The City reserves the right to charge the User supplemental fees for the use of additional rooms, locker rooms, ice maintenance, utilities and clean-up expenses.
- b. **Sale of Food and Beverages.** The City has the exclusive right to operate concession sales at BIG for the sale of food and beverages, including food and beverages dispensed from vending machines.
- c. **Advertising.** No advertising by the User in or on any part of BIG is permitted without the express written consent of the City.
- d. **Parking Lot Usage.** The User has non-exclusive right use of the BIG parking lot on a first come, first served basis and may not prohibit the use of the parking lot by any others.
- e. **Alcohol/Tobacco Use.** Alcohol and tobacco use are not allowed at BIG.
- f. **Compliance with the Law.** The User agrees to comply with the Americans with Disabilities Act ("ADA") and Section 504 of the Rehabilitation Act of 1973 ("Section 504"), both as amended, and all other applicable laws, including but not limited to Minnesota Statutes Chapter 363A. The User agrees to hold harmless and indemnify the City from costs, including but not limited to damages, attorneys' fees and staff time, in any action or proceeding brought alleging a violation of this paragraph. Upon request, User will provide a reasonable accommodation to allow any individual with disabilities to participate in all services, programs and activities. The User agrees to utilize its own text telephone or the Minnesota TTY Relay Service in order to comply with accessibility requirements. The City has designated coordinators to facilitate compliance with the ADA and Section 504.

16. NOTICE. All notices required or permitted to be given under this Agreement shall be in writing and shall be deemed to have been duly given if delivered in person or deposited in the United States Mail, postage pre-paid, as follows:

17. SIGNATURES/EXECUTION. Each person executing this Agreement on behalf of a party hereto ("Signatory") represents and warrants that such person is duly and validly authorized to do so on behalf of such party, with full right and authority to execute this Agreement and to bind such party with respect to all of its obligations hereunder. In the event the User did not authorize the Signatory to sign on its behalf, the Signatory agrees to assume responsibility for the duties and liability of the User, as set forth herein, personally. This Agreement may be executed electronically and in counterparts, each of which shall be deemed an original, but all of which taken together shall constitute but one and the same instrument.

IN WITNESS WHEREOF, the City and the User acknowledge that they have read, understand, and agree to abide by all its conditions stated in this Agreement and have caused this BLOOMINGTON ICE GARDEN RENTAL AGREEMENT to be executed by their duly authorized representatives in duplicate on the respective dates indicated below.
