### **WORK DUTIES**

It is mutually understood and agreed that:

- The contractor shall place Amanda Leveille on site to perform all duties of goaltender coach for the 2019-20 season of Bloomington Jefferson High School.
- The contractor, will provide goaltender feedback through games and practices
- Provide feedback to the coaches on their goaltenders progress throughout the season
- attend some games and provide immediate feedback to the goaltenders
- Will use her goaltender skills and knowledge to develop unique drills catered to the goaltenders at the agency.
- Amanda will not conduct off ice individual meetings with goaltenders

### **TIME**

It is mutually understood and agreed that:

- Amanda Leveille is exempt from all or any activities related to the agency that conflict with her NWHL and or OS Hockey Schedule.
- Amanda Leveille will attend 1-3 practices a week depending on her Minnesota whitecaps schedule.
- Amanda Leveille will notify the agency if there is a conflict between the agency and the NWHL 1 week prior to the conflict.

### **COMPENSATION:**

It is Mutually understood and agreed that:

- The cost of service of Amanda Leveille is 3,500
- The Agency will pay the contractor once a month starting November 1st.
